Welcome and thank you for your interest in becoming a vendor at the 120th Old Settler's Celebration. The celebration will take place August 10, 11, & 12, 2007.

All vendors are required to register and receive a license from the Old Settler's Committee. All registrations/license requests must be approved by the Old Settler's Committee. When approved by the committee the license will be mailed to you or can be picked up as arranged with the committee. We will require that the license be visible on your booth or person at all times while you are in operation during the Old Settler's Celebration. Licenses will reflect vendor type clearly on the front. Only vendor's licensed by the Old Settler's Committee will be allowed to operate during the event. Not For Profit groups must be recognized by the Committee.

Anyone found during the three-day event without a license will be assessed the appropriate license fee plus \$5.00 to continue to sell during this event. In the event that the group or individual chooses not to purchase a license, they will be asked to leave the event.
